Dear Fillmore Central School community,

I have recently found myself reflecting and reminiscing on my children's experiences as FCS students. I am not often one to reminisce or get sentimental about much of anything (my wife can confirm), but as we are nearing the final collegiate days of my two youngest, I can't help but think back on how FCS has helped prepare my kids to survive in our world today. All five of my children attended FCS and all have fond memories.

hile it is hard to believe, as is always the case-so why do we struggle!, summer is all too quickly ending! For the delight or despair of any given individual, life keeps coming around, and school is soon to be here again. So whether, summer is a time with new routines or without routines, FCS will be back into the normal flow of school life. Welcome back!

While you may have read what Brian Reitnour wrote in the newsletter before being elected, as is our practice, I want you to hear from him upon starting his term of office.

It is always a pleasure to allow newly elected board members to introduce themselves. Even though Brian Reitnour has a long history in the community, it is good to hear from him in this new role. Enjoy the conversation!

Marcus: Brian, welcome to the FCS Board of Education. We appreciate your willingness to take on this important assignment as a volunteer. This is a great opportunity for the FCS community to learn more about you. So, for our first question; How long have you been connected with Fillmore Central School?

Brian: My three older siblings all enrolled at FCS when we moved to Fillmore in 1980. I personally enrolled in September 1983 and have had some member of my family either attending or working here since that time.

Marcus: It seems that few people are willing to commit to being on the school board. For you personally, what led you to run for the Board of Education?

Brian: The people of this community have given more to me than I could ever repay, but they, along with my mother, taught me that a life of service is better than a life of self-interest. When my family and I returned to Fillmore I wanted to pay forward some of what was given to me. FCS is, and has been, the lifeblood of our community; while serving on the board will certainly have its challenges, I believe that it is necessary, and a way in which I can use my abilities and experience to serve our community.

Marcus: This might be interesting; how many ways are you connected to FCS? And how do you think this will influence your involvement on the board?

Brian: Wow, I'm not sure how deep to go with this one. In my immediate family, my siblings and I all attended and graduated from FCS; my mother taught first and second grade at Fillmore for nearly 30 years; my wife served has served as a substitute teacher and a teacher's aide; and my daughters have both attended FCS (my youngest daughter will enter her freshman year this fall). FCS has provided opportunities for us in a wide array of academic pursuits, as well as athletics, vocal and instrumental music, drama, art and more.

I am connected in a wide array of areas and relationships. Balancing those relationships with the responsibilities of this position will be challenging, I'm sure, especially when making decisions that will impact people with differing opinions. I believe those connections will create a greater sense of empathy in how the decisions made by the board impact students, teachers, administrators and staff members at FCS, as well as our community as a whole. I believe it is the responsibility of the members of the BOE to listen well, ask pertinent questions, and attempt to support and guide FCS through informed conviction of the collective values of our community.

Marcus: With your background with FCS; What do you think you will be able to contribute to FCS as a board member?

Brian: FCS, its students, teachers and administrators have a history of impressive accomplishments. One of my most important contributions will be to affirm the positive work done at FCS and build up those responsible for such accomplishments. All of us need to know we are valued. Additionally, I believe there are bridges to be built within our communities. In order to build those bridges, it will require me (and all of us) to listen well, and part of listening well is asking appropriate questions. If we want to move forward, we must not only recognize excellence, but find ways to improve. We must be honest with ourselves and each other.

I have a unique perspective of our community in that I grew up 50 yards from FCS, currently live between Hume and Centerville, and work in Houghton. I am a lifelong educator, but I love a wide array of things offered in our community, from sports to agriculture, literature, music, and taking walks in the woods with my dogs. This is my home. I think I have an understanding of the people who live here because I am one of them. I spent a long time in other areas in my early adulthood, but I chose to come back, on purpose.

On a very practical level, I have experience evaluating and crafting policy, balancing budgets and making difficult decisions. I believe all of those skills will be necessary in this position.

Marcus: Is there anything else you would like to tell the community as you embark in this service to FCS?

Brian: We live in challenging times. Division during these times is easy. Many in our community, and especially the students, teachers and administrators in our schools are struggling. But there is hope. One of the hallmarks of true community is resilience, and I see that all around me every day. I have seen this community persevere through many storms, continuing to sacrifice and give to their neighbors. I am honored to be a part of this community, and to serve them in this role.

Thanks Brian. May we all keep our focus on contributing to making FCS a better place.



"BACK TO SCHOOL" INFORMATION

It is hoped the following information will be helpful in the transition back to school.



The **first day of school** for students Pre K-12 will be **Tuesday, September 5, 2023**. Students should be in their classrooms no later than 8:10 am. The buses will arrive at school by 8:00 am. Breakfast and lunch will be served on the first day of school.

Students in grades 7-12 should report directly to their first period class as noted on the student's schedule which will be mailed to them. Any secondary student who has not received a schedule should report directly to the Guidance Office. Morning BOCES Career and Technical Education students should report directly to the bus.

Students in grades Pre K-6 should report to their assigned grade levels and teachers as noted in this newsletter.

Please note that the application for the Community Eligibility Provision form is included in this newsletter. If you believe your family qualifies for this program, please complete the application and return it to school as quickly as possible.



Parents/Guardians:

It is essential that we keep our school records of your child(ren) as current as possible. Please report any changes in your address, phone number, or guardianship of your children during the school year to the appropriate office as soon as possible. ALL INFORMATION IS CONFIDENTIAL.

If any changes have occurred since last school year, please notify either the PK-6 office or the 7-12 office. Also, if you anticipate moving from our district anytime during the school year, please inform the appropriate office (PK-6 or the guidance office for 7-12th graders) as soon as possible as to the date you expect to leave the district. This information is helpful in preparing transfer documents for your children.

No person in the Untied States shall on the grounds of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be subject to discrimination under any program or activity receiving federal financial assistance, or be so treated on the basis of sex under most education programs or activities receiving federal assistances.

REQUIRED IMMUNIZATIONS FOR SCHOOL ATTENDANCE

Regular checkups are a necessity to insure your child's good health and normal development. Immunizations are an impor- tant part of these visits.

As a reminder, the following vaccines are required for your child to attend school:

- 3 doses of diphtheria containing toxoid (4 doses for New York City Schools)
- 3 doses of poliovirus vaccine
- 3 doses of hepatitis B (K-12 students born on or after 1/1/93 and children on or after 1/1/95 beginning with their enrollment in any school)
- 2 or 3 dose series of hepatitis B vaccine is required for all students entering seventh grade
- 2 doses of measles vaccine
- 1 dose of mumps vaccine
- 1 dose of rubella vaccine
- 3 doses of haemophilus influenza type b (Hib) conjugate vaccine for all children less than 5 years of age who are enrolled in a daycare, pre-kindergarten or nursery school. For a child who is 15 months or older, it is acceptable to have received a single dose of the vaccine at or after the age of 15 months.
- 1 dose of varicella vaccine for all children born on or after 1/1/00 and enrolled in any school. Also for all children born on or after 1/1/98 and entering kindergarten in September 2023.

Proof of these immunizations must be in the form of a certificate by a physician; this proof must be presented before any child will be admitted to school in September. Children who have not completed the immunization program by September 5, 2023 will not be admitted to a kindergarten room until proof of full immunization is presented to the school nurse.

Section 2164 of the Public Health Law addresses students transferring into a school district from another state or country. A school may grant a student entering New York State schools from another state or country permission to attend school for a period not to exceed 30 days provided such student can show a good faith effort to get the necessary certification or other acceptable evidence of immunization. The permission for a "grace" period does NOT apply to students transferring within New York State.

The intent of this law is to increase the immunization levels of children and thereby protect children from serious vaccine-preventable diseases.

SCHOOL CLOSINGS AND DELAYED OPENINGS

There may be times when it is necessary to close school or delay the opening of school. Please note the following procedures regarding delayed opening and/or closing of school.

ONE HOUR DELAY in school opening (the school day will begin at 9:10 a.m. instead of 8:10 a.m. with the school buses running approximately one hour later). **TWO HOUR DELAY** in school opening (the school day will begin at 10:10 a.m. instead of 8:10 a.m. with the school buses running approximately two hours later). When it is necessary to CLOSE SCHOOL because of inclement weather or for other reasons, it will be announced over the radio and TV stations listed below. It may be necessary also to close school and send the children home prior to regular dismissal times. If you aren't home during the day, we should be informed as to where your children should go. Emergency forms were sent home with your children at the start of school. If you have any changes to that information, please call the appropriate office. IT IS IMPORTANT THAT THIS INFORMATION IS KEPT CURRENT. This information is needed for your child's safety and protection. Announcements concerning delayed openings or closing of school will be announced on the following radio and

ILLNESS

Some reasons to keep your child home from school:

- Complaints of not feeling well, accompanied with a fever or any other symptoms.
- Upset stomach-vomiting
- Red crusty eyes (pink eye)
- Fever of 100 degrees or higher (must be fever free for 24 hours **without** medication)
- Unexplained rash
- Flu or cold symptoms
- Head lice (they cannot return to

school until they are checked and cleared by the school nurse) FCS has a no nit policy

• Any other contagious illness If your child is sent home from school due to illness please do not allow him/her to return to school the next day.



As a part of your child's requirements for school, a physical examination is required for new students from out of the state, as well as students in Pre- Kindergarten or Kindergarten and in grades 2, 4, 7 and 10. A law was enacted that expands health screenings to include the dental health of students in New York State.

When we require that your child have a physical examination, we will be requesting a dental certificate as well. There is a certificate available for you to take to your child's dentist and once it is completed, it should be returned to the School Nurse as it will be filed in your child's Cumulative Health Record.

All students enrolled in 6th grade who are 11 years old must have a Tdap vaccine and all students enrolled in 6th grade regardless of age must have 2 Varicella vaccines. Both vaccines can be obtained at your family doctors or the health department. Without both vaccines your child will not be permitted to start 6th grade.

This vaccine needs to be obtained by September 5, 2023.



The program is designed to benefit those who are uninsured, who do not have transportation, or have difficulty accessing dental care.

Education and prevention are two of our main goals for our program. Dental

health/nutrition education is offered in the classroom setting to all students and staff. The dental health presentation is evaluated by the staff and then shared with our quality assurance committee, school administration, public health directors and the State Department of Health.

A thorough medical history and authorization form is sent home with each student. These forms must be completed by a parent or guardian and returned to the school prior to any dental services. All the forms can be found on the FCS website under the Health Office.

A free dental screening is offered to each student along with a toothbrush, floss and instructions. The parent/guardian may also choose to have a dental exam by a pediatric dentist that will complete a dental certificate. The parent may also chose to have a dental cleaning, fluoride treatment, and/or dental sealants if recommended for their child. If additional treatment is necessary (ie: restorations dental fillings, extractions, and/or orthodontics) a referral list of dental providers will be sent home and a phone call will be made to the parent/guardian to help the family find a dental home.

We are responsible for all billing of services. Payment for services will come from either the patient's insurance company, Child Health Plus, Medicaid, BC/BS Dental Insurance or directly from the patient. A sliding fee discount is also available.

If you have any questions about this program please give the school nurse a call. It is a wonderful program and I encourage all that do not have a regular dentist to apply. It is free to most that apply with a sliding fee for those that don't qualify for the free program. You will not be billed until all procedures are explained to you and the possible charge is explained.

Please take a few minutes to check out the FCS website under the health office heading. You can access forms to print and return as well as information on several different topics.

The NY State Education Department regulates the administration of all medications (prescription and over-the-counter, including cough drops) and has detailed regulations in the administration of medications in public and private schools. Our Policies below are based on those mandates.

- Parents and physicians are required to attempt to arrange all medication/ treatment administration around school hours. Drugs requiring three times a day administration are to be given before school, after school and before bedtime.
- All physicians' orders must be in writing; verbal physician orders are not accepted.
- The School Nurse (or trained school personnel under the supervision of the school nurse) must administer all prescriptions and over-the-counter medications.
- All medication is administered in the Nurse's Office. Parents arriving at school to administer medication to their child must do so in the Nurse's Office.
- Narcotic (opiate) medications, such as Vicodin (hydrocodone), Oxycontin (oxycodone), etc. are very potent pain relievers. No child taking these medications is allowed to come to school while taking them. These drugs will not be administered at school, are not to be brought to school, or taken when coming to school, to do so is in direct violation of our school policies.
- All medications, whether prescription or over-the-counter, (OTC medications include but are not limited to: Tylenol, Advil, cough drops, Chloraseptic, Anbesol, topical ointments and sun screen) requires a physicians order for school administration as well as parental consent. When a child has multiple medications each medication ordered

requires a separate form. Forms are available on the school web site and the school nurse's office.

- The physicians order must include the name of the student, the name of the medication, doses, route, and time to be administered during the school day.
- It is the parents/guardians responsibility to be aware of any expiration dates on medications they provide for school administration and to provide the school with up-to-date medication prior to any expiration dates.
- Management plans (diabetic, asthmatic, allergy, etc.) are not acceptable physician orders. Physician order forms are required for all medications and treatments.
- All medications, including overthe-counter medications, are to be delivered to the school nurse by a parent. This is state law. Please, DO NOT send any medication to school with the student.
- Medications need to be in original prescription bottle(s) or original over-the-counter bottle(s). Pharmacies will provide "school bottles" if requested. The container must be properly labeled with the students name, name of medicine, dose and time to be administered.
- All medication is kept in the Nurse's office. No student is to carry any medications, prescribed or over-the-counter, on their persons, in their backpacks, or lockers.
- Children with life threatening issues who must carry emergency medications on their persons are allowed to do so only with physician and parent written authorization.
- The school has a nebulizing machine so students with the appropriate physician orders and parent consent may receive these treatments during school. Parents are required to provide the individual tubing, medication reservoirs, and any associated medications.

- New medications orders must be provided for each school year. All medication orders expire the last day of school at which time all medications must be picked up by parents/ responsible adult. Any medication not retrieved after close of school on the last day of school is destroyed. Discontinued medications must be retrieved by parent/guardian within one week of discontinuation. After seven days medication will be destroyed.
- Our school physician provides standing orders for over-the-counter medications for pain relief and fever. The purpose of these medications are to assist children to complete the school day when suffering minor headaches, pain, menstrual cramps, etc. These medications are available to students only with parental written request. The Standing Order Parental Permit forms are issued at the beginning of the school year.
- Our school physician will also provide a Non-Patient Specific order for anaphylactic agents (epinephrine, Benadryl), Albuterol Metered Dose Inhalers and liquid Albuterol for use in a nebulizer. This order is for emergencies only.

ANNUAL PESTICIDE NOTIFICATION [EDUCATION LAW 409-H]



PESTICIDES

State Law now requires us to notify everyone who occupies the school building of all applications of pesticide chemicals and the district pest control policy. The maintenance department at Fillmore Central School is trained and well aware of the potential hazards of casual or careless use of pesticides. We have a pest control policy that focuses on prevention without chemicals.

The Pesticide Notification Law deals with the most hazardous pesticide products and chemicals. In our routine control plan Fillmore Central School does not use any pesticide products in the school buildings that would require notification. Control of insects is achieved through good housekeeping, sanitation and maintenance. However, in the spirit of the regulation we want to inform parents that we do, when necessary, use the following approved products to control ants, cockroaches and other unwanted insects: baits, jells and granular products that contain boric acid and/or disodium octaborate tetrahydrate. We may also use growth regulators so that pests do not mature and breed if they hatch out from eggs brought into the school on food products, containers, or by persons entering the building. Also, at times it is necessary to use an aerosol product to protect our students and staff from stinging and biting insects. Any application of a pesticide will be done by certified pest control applicators, or in an emergency, by trained staff.

Good housekeeping and sanitation practices also achieve primary rodent control. If necessary, only mechanical trapping devices will be used, never poison baits.

Weeding will control unwanted vegetation: herbicides will be used only to control poison ivy or other harmful plants. Herbicides, when used, will be done over the summer recess or a long weekend to nullify any exposure. We apply only fertilizer and a mild crabgrass control to our playing fields.

In the unlikely event of an infestation of insects or rodents that threatens the health and safety of our students and staff or could cause significant monetary damage to our building or grounds, then other control methods might have to be used. Such control methods may require the use of pesticides other than those listed above. We are required to give forty-eight hours notice of the use of such products to employees and adjoining property owners. Parents who wish to be informed of the use of such pesticides may request 48 hours notice by completing the form BELOW. All use of pesticides will be closely monitored and if possible, done when the building is unoccupied.

This notice is to inform you of the district's plan to use the least toxic approach to pest control. The district has a comprehensive plan in place to inspect for, monitor, and control pests designed to protect the health and safety of all building occupants.

TRANSPORTATION INFORMATION



- As soon as students are dismissed from school, they are to go directly to their buses. Do not push or crowd getting on the bus or within the bus.
- Once on board the bus, students are to go to their seats in a quiet and orderly fashion.
- Students are to read, do homework, sit or talk quietly.
- Observe same conduct as in the classroom.
- Be courteous; use no profane language.
- Do not eat or drink on the bus.
- Keep the bus clean.
- Do not smoke.
- Do not be destructive
- Do not move to another seat. Remain in your seat until you get to your stop [home].
- Keep head, hands and feet inside the bus.

- Make room for others to sit in your seat when there is room.
- Put your books in your lap and hold onto them instead of leaving them on the seat if someone needs a seat.
- Don't throw anything on the bus or out the windows don't litter.
- Cooperate with the bus driver.
- The bus driver may give other directions as necessary.
- The bus driver is authorized to assign seats.
- Violation of these rules will result in disciplinary action possibly jeopardizing a student's privilege of riding the bus.



The NYS Department of Transportation requires certain regulations concerning items, which may be transported on our school buses. We want to comply with these regulations while permitting students to carry necessary items on the school bus whenever possible. Generally, baggage may be carried on the bus, which can be held comfortably on the student's



lap. Most items that are too big and/or bulky to be carried on the lap may be tied down under the seat or secured by other means. No items may be permitted which protrude into the aisle hampering normal or emergency exiting. Some items, which may NOT be carried on our school buses, are glass containers, flammable products, and aerosol cans, etc.

The Department of Transportation indicates that the person that should have responsibility for determining what will be carried on the school bus is the bus driver. Any questions may be directed to your child's driver or Mr. Potter, Transportation Supervisor at 567-2276.

Why Wrestle? students thrive at summer wrestling camp

By: Jarrett Vosburg, Wrestling Coach n July 31st, nineteen students in third through eighth grade wrapped up our third annual summer wrestling camp. The eight-session event provided an opportunity for those who have never experienced wrestling to get their feet wet and learn the basics while simultaneously facilitating growth in those more experienced with the nuances of the sport. Throughout the month of July, wrestlers learned and practiced a variety of take-downs, breakdowns, pinning combinations, and escapes. As I reflected on my time spent coaching the next generation of Fillmore wrestlers this past month, I found myself pondering the many benefits of wrestling. For those unfamiliar with the sport, or even those that have been around it for decades, I share my thoughts on the question: *Why* do we wrestle?

- 1. Wresting is fun. There is just something about hanging out with your friends and pushing each other to be the best you can possibly be physically, mentally, and tactically. Wrestling first became an Olympic Sport in 708 B.C., surviving the test of time as one of the purest indicators of physical dominance over an opponent.
- 2. Wrestling promotes great sportsmanship. There is a reason every wrestling match starts and ends with a handshake. Wrestlers learn to be humble in victory and resilient in defeat.
- **3.** Wrestling builds physical fitness. Want to get in great shape? Sign up for wrestling. The sport uses a wide variety of muscle groups, requires great cardiovascular fitness, and improves flexibility. Our Modified and Varsity wrestlers leave wrestling season in the best shape of their lives.

- **4. Wrestling teaches accountability.** There is no one to turn to but yourself in a wrestling match and no bench to hide on in the center of the mat. When you fall short, you learn how to self-evaluate your mistakes rather than making excuses or blaming others.
- **5.** Wrestling is a microcosm of life. Life gets hard for everyone. By battling through adversity and overcoming the challenges a wrestling season throws at you, you are more likely to succeed when life throws up roadblocks, and more likely to appreciate the simple things life throws your way.

I would like to lend a special thank you Mike Witkowski, Mike Uveino, Gary Nageldinger, Ryan Marriott, and Cody Marriott for coaching this summer. Thank you to the Sports Boosters and Varsity Club for enabling us to host the camp, and to all of the parents for allowing us to work
