2. PROGRAMS/PRESENTATIONS

2.1 ARC Presentation – Kim Crowner and Janelle Smith Dr. Bowen introduced the ARC representatives who reviewed how students are referred to the program. Both the Adult and After School programs gave realized an increase of three participants this past year. The Saturday program has realized an additional four children which increases the average attendance to 12. Kim spoke on the broad range of services ARC provides and that they continue to seek property which can be used for public access in the northern part of the county. They desire to continue the relationship with the school district, providing limited services at Fillmore Central.

- 4.1. Superintendent's Report
 - Dr. Bowen reminded the Board of the current mandated testing that has been occurring in grades 3-8.
 - A meeting has been scheduled with Fillmore Faculty Association leadership in regards to an upcoming grievance arbitration hearing. The goal of this meeting is to clarify the circumstances that led to the hearing and possible resolutions that would negate the need for a hearing.

- Allegany County superintendents will schedule a synchronized superintendent's conference day on September 24. This will affect our adopted calendar for next year, and therefore will require your official action to amend the calendar.
- Elementary teachers are planning a field day on June 18.
- Allegany County Historian Craig Braack is scheduled to visit 4th grade class rooms on June 11 and the 4th graders will visit the Hume museum on June 13th or 14th with a local bus tour and commentary by Hume town historian Rhondus Miller.
- Petitions for Board elections have been received by Bridgette Tojek and Sara Hatch.
- Next weeks NYSBBA paper "On Board" should publicize our opening for superintendent. The deadline for applications is May 4.
- There was also discussion on the impact that transitioning students will have on APPR outcomes, which has yet to be determined.
- CSEA unit contract negotiations have been scheduled.
- After further review of the contracts and business plan of the "Miles for Smiles" in school dental program, school Attorney David Pullen has recommended that we proceed with implementing the program beginning the fall of 2012 with minor changes.
