### 2. PROGRAMS/PRESENTATIONS

• FCS teacher Mrs. Peters along with students Alexis Rawlings and Lexi Allen shared their experience and testimony about the Writer's Workshop curriculum and the positive impact it has had on student writing. Lexi and Alexis shared examples of their progress since beginning the program last fall. Mrs. Peters reviewed several units that were covered this past year and also spoke to how Writers Workshop enhances the Common Core curriculum already being utilized.

- MS & HS honors assemblies were attended well with many awards being handed out.
- Various student handbooks are being reviewed for edits by teachers and administration for corrections and updates.
- A distracted driving seminar was presented by the NY State Police to high school students at the school the day before Prom.
- Prom went well with a good turn out and no incidents.
- Plans for the 2015 Graduation ceremony, scheduled for June 26 at 7:00 pm, are beginning. Approximately 46 students are slated to walk the stage this year, receiving their diplomas.

#### 3.2 Work Session

• DASA Policies #7550 and 7553 were reviewed highlighting changes and revisions for the upcoming year.

- A draft of the District Goals for 2015-2016 that were developed at our recent retreat. The
  goals were reviewed for content and to make sure it contains the ideas that were
  discussed. Goals will address the following areas: for Instruction and Learning, Technology,
  Culture and the Capitol Project.

- **WHEREAS**, The Board of Cooperative Educational Services and Boards of Education wish to appoint a committee to assume the responsibility for drafting of specifications, advertising for bids, accepting and opening bids, tabulating bids, reporting of the results to the Board of Cooperative Educational Services and Boards of Education and making recommendations thereon; therefore,
- **BE IT RESOLVED,** That the Fillmore Central School Board of Education hereby appoints the Cattaraugus/Allegany Board of Cooperative Educational Services to represent it in all matters related above, and,
- **BE IT FURTHER RESOLVED,** That the Fillmore Central School Board of Education authorizes the above mentioned committee to represent it in all matters leading up to the entering into a contract for the purchase of the above mentioned supplies, commodities, and/or services, and,
- **BE IT FURTHER RESOLVED**, That the Fillmore Central School Board of Education agrees to assume its equitable share of the costs of the cooperative bidding, and,
- **BE IT FURTHER RESOLVED,** That the Fillmore Central School Board of Education agrees (1) to abide by the majority decisions of the participating districts on quality standards; (2) that unless all bids are rejected, it will award contracts according to the recommendations of the committee; (3) that after award of contract(s) it will conduct all negotiations with the successful bidder(s).
