A regular meeting of the Fillmore Central School District, Board of Education was called to order at 7:00 pm by President Tom Parmenter.

Comments from Visitors

BOCES instructor Jenn Wolfer addressed the Board in support of continuing to provide FCS students enrichment programming and opportunities. Mrs. Wolfer provided an article that encourages public educators to consider the benefits of individualized enrichment to students that show higher standards of achievement.

Mr. Cahill, father of 4 current FCS students, also addressed the Board in support of continuing to providing enrichment to FCS students. As some of his children are involved with several groups within the enrichment program, he encouraged the Board to consider the benefits to students.

Superintendent's Report

Principal Faulkner updated the Board on the progress of the high musical Oklahoma with performances scheduled for March 31, April 1, and April 2.

Mr. Faulkner also forwarded along statistics from Athletic Director Jon Beardsley demonstrating the high level of academics that FCS athletes have accomplished this past year. There were a total of 81 varsity and junior varsity athletes during the winter season. Their combined academic average was an impressive 91.90%. The boy's basketball team averaged an average of 96.63%, and has earned them the #1 slot in New York State.

Superintendent Cox continued the report by briefing the Board on progress of the softball field/gym lighting project. Drawings for both parts of the project have been submitted to New York State Education Department (NYSED). Rod Drake, Habiterra Architect estimates that once the project is assigned, and receives final approval from NYSED, bidding may take place by late April.

Mr. Cox encouraged all FCS employees to contact our local representatives, Senator Cathy Young and Assemblyman Dan Burling and ask them to consider the implications to rural schools if the Governors proposal for reducing school aid is approved. Under Gov. Cuomo's proposal, the average per pupil loss in NY State aid will be \$1,484 in Allegany County compared to \$722 in Westchester County.

Both the Fillmore Faculty Association and the Fillmore Unit of CSEA have their respective presidents enter into agreement with the Proposed MOA between the District and each unit as it pertains to a Retirement Incentive that has been approved by the Board of Education as of February, 2011.

Mr. Cox reported that Mrs. Walters's class has partnered with the Circle of Life School in Kampala, Uganda which was founded by Joanita Senoga in 1994. Ms. Senoga will visit FCS on April 1 at an assembly to talk with students about her school.

Faculty Development is scheduled for Friday, March 18 with a focus on core curriculum standards for academic year 2011-2012.

2011-12 Budget Proposal

Business Manager Tom Ricketts presented a proposed draft of the 2011-2012 budget, including all three sections.

- A. Program reduced by \$191,076 or 1.99%
- B. Capital reduced by \$47,675 or 1.56%
- C. Administrative increased by \$12,499 or 1.29%. This is due to an increase in the BOCES administrative budget.

Mr. Ricketts reviewed each section, explaining increases and decreases along with an explanation of total revenue and their source.
